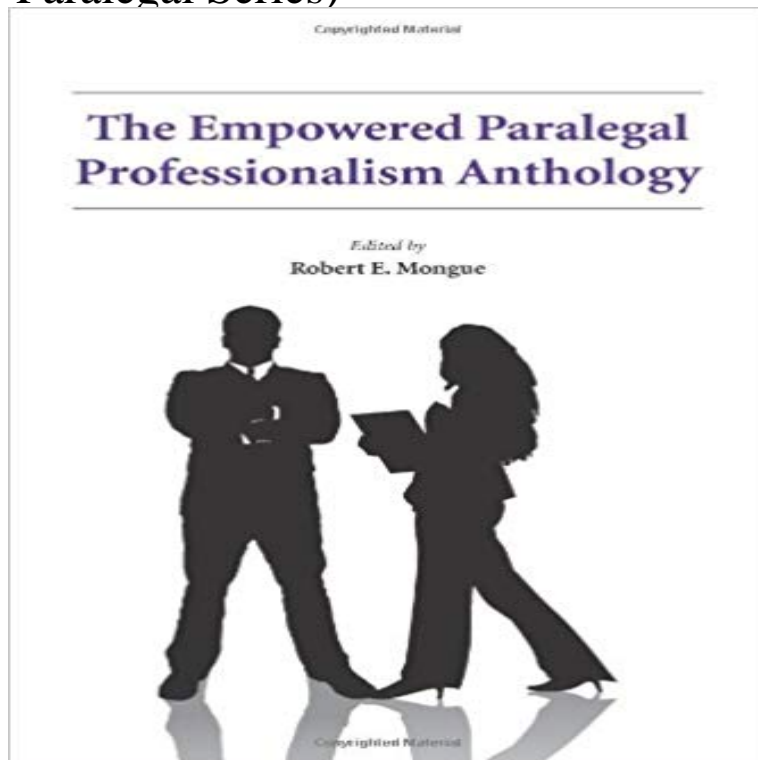


# The Empowered Paralegal Professionalism Anthology (The Empowered Paralegal Series)
