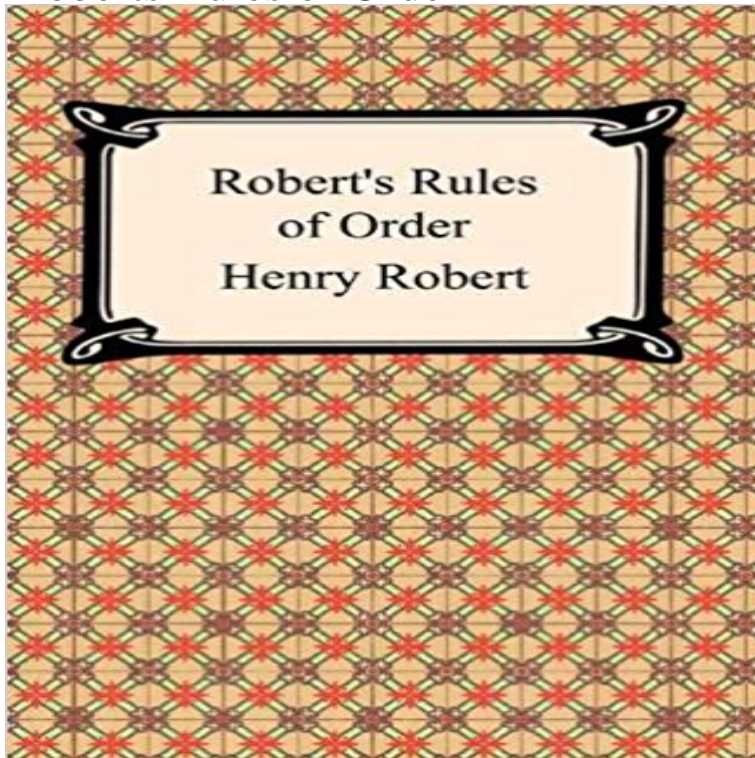


Roberts Rules of Order
