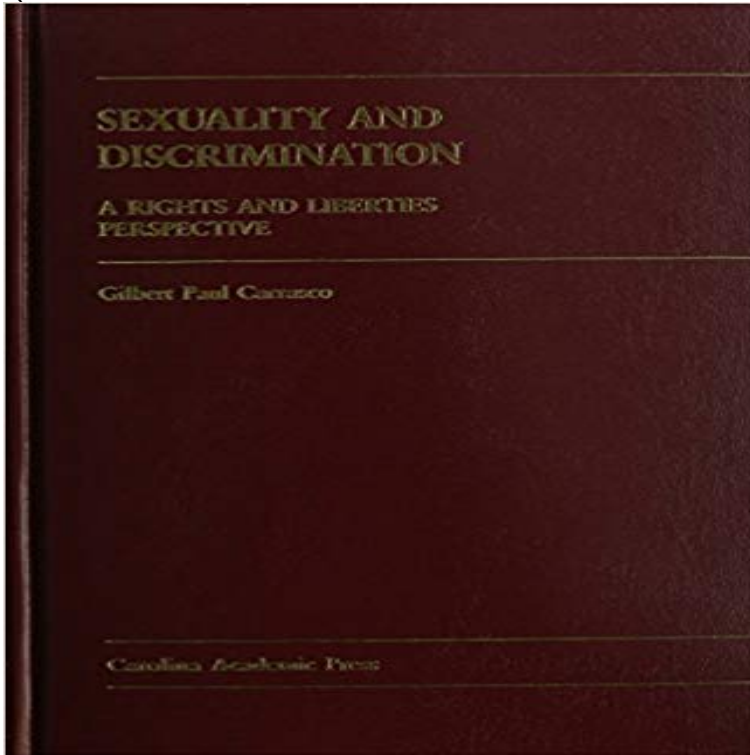


# Sexuality And Discrimination: A Rights And Liberties Perspective (Carolina Academic Press Law Casebook Series)

Cases decided by state, foreign, and various federal courts are analyzed against the backdrop of an emerging paradigm of equal protection of the laws that continues to develop in the United States Supreme Court. The book also considers the intersection of sexuality and AIDS and discrimination against pregnant women.
