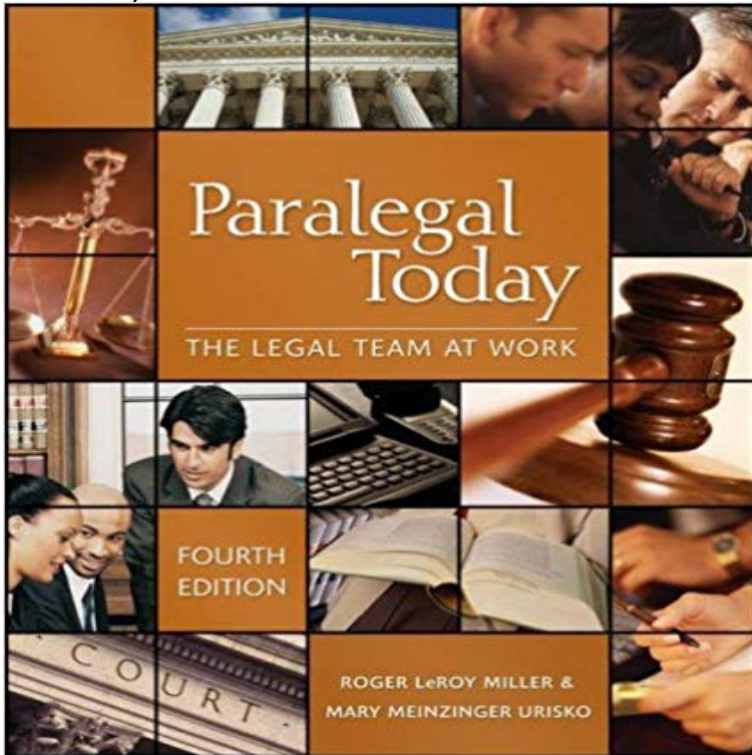


Paralegal Today: The Legal Team At Work, 4E (West Legal Studies Series)
