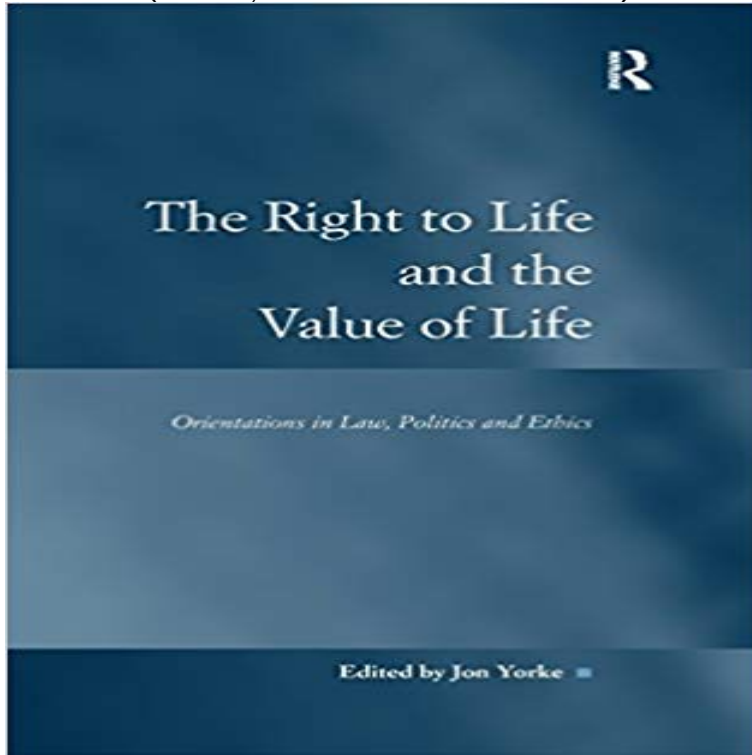


The Right to Life and the Value of Life: Orientations in Law, Politics and Ethics (Law, Justice and Power)
