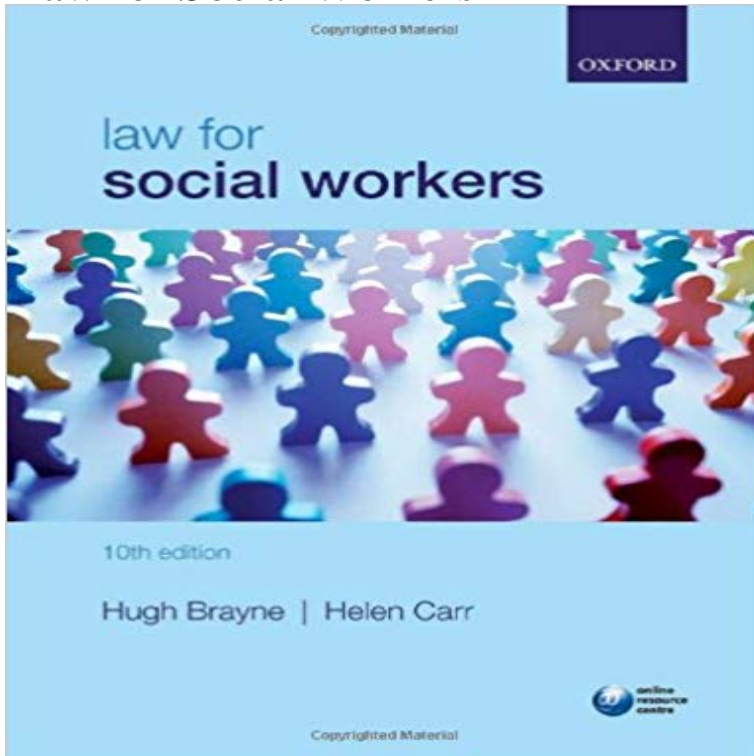


Law for Social Workers
