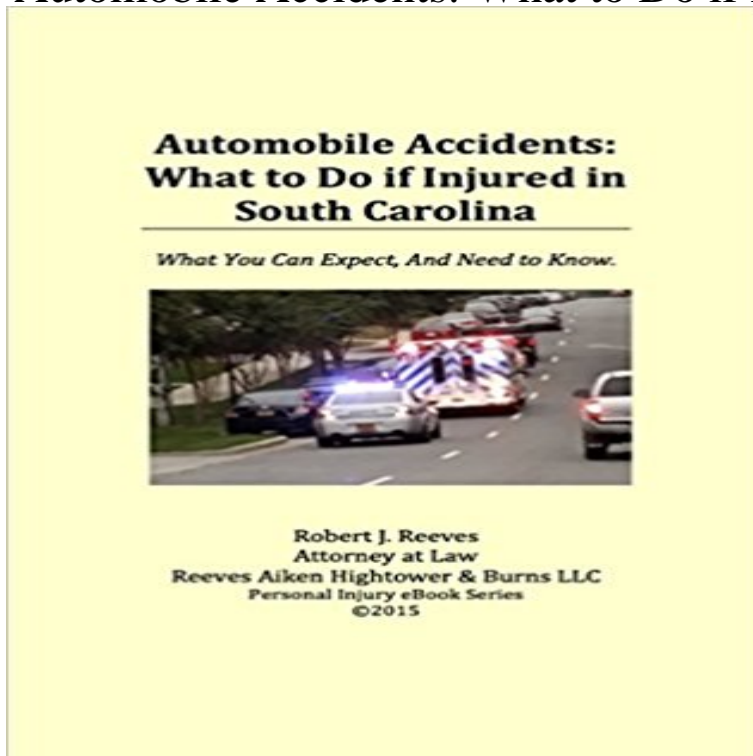


Automobile Accidents: What to Do if Injured in South Carolina
