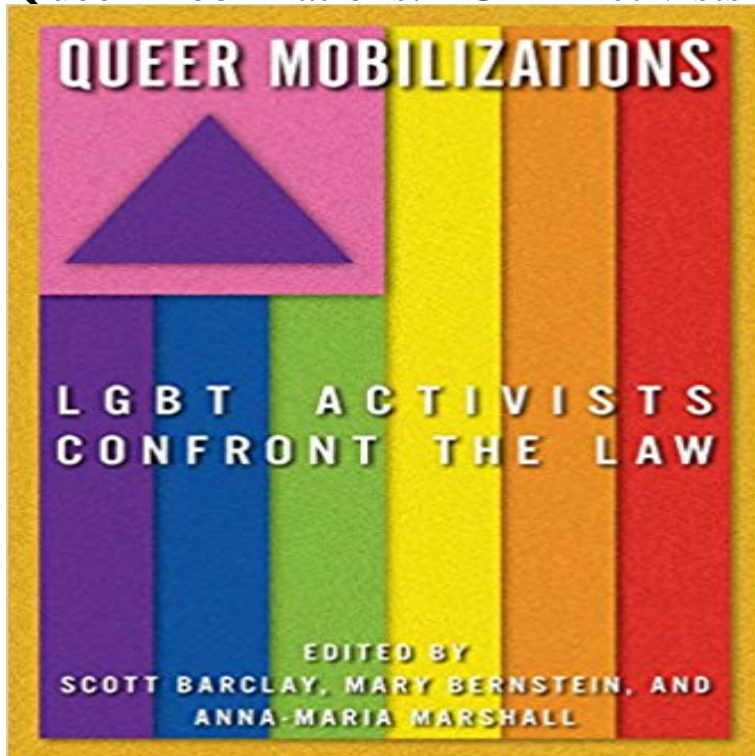


## Queer Mobilizations: LGBT Activists Confront the Law
