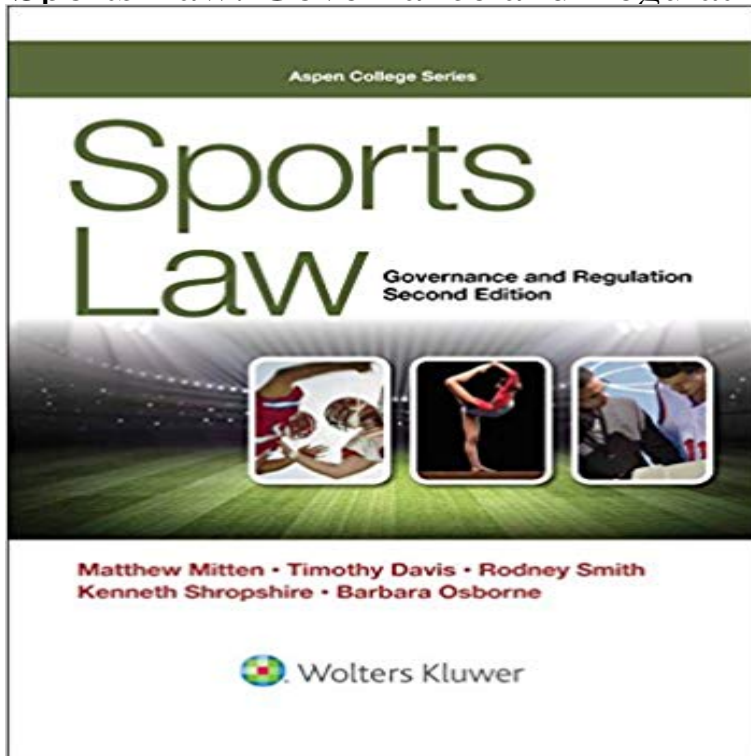


Sports Law: Governance and Regulation (Aspen College)
