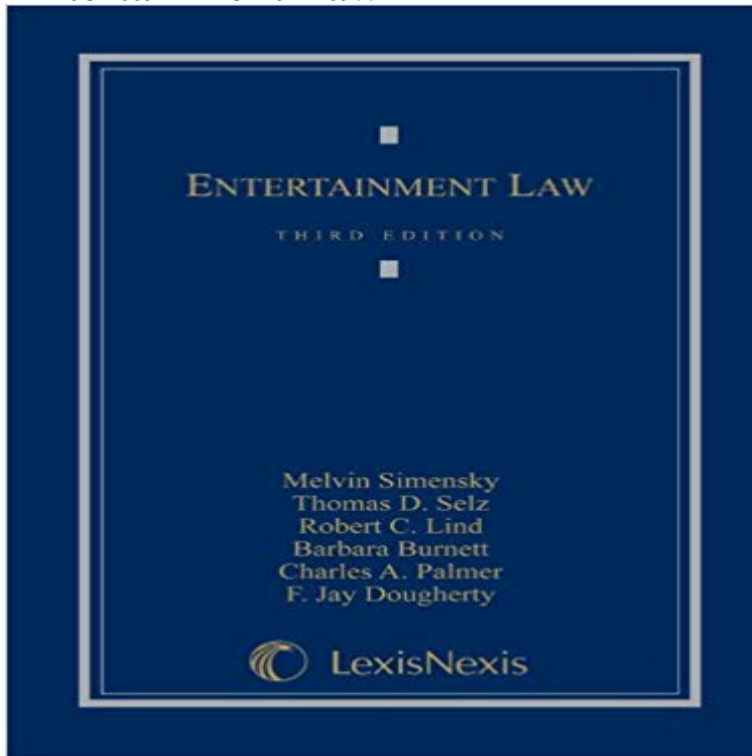


Entertainment Law
