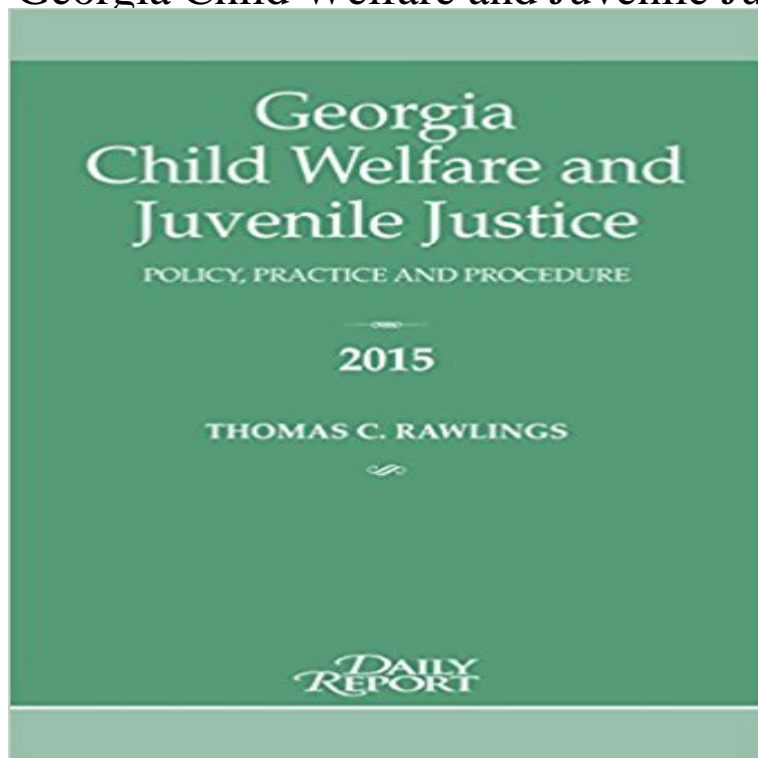


Georgia Child Welfare and Juvenile Justice



This book describes Georgias system of identifying, managing, treating, rehabilitating, and protecting children. The system is complex, and to cover it requires exploring federal and state law and regulations; explaining the work of numerous federal and state agencies; investigating the roles of courts, attorneys, judges, volunteers, and providers; understanding the intricacies of family relationships and child development; considering the effects of mental illness, trauma, drugs, incarceration; and searching out the best methods to treat troubled children and dysfunctional families. Chapters include: Child Development and Children in Court, Juvenile Delinquency, Dependency, Children in Need of Services. The Juvenile Court. Dependency Forms, CHIN S Forms, and Uniform Juvenile Court Forms are included in the book and on the accompanying CD. The book also includes a case table and index.
