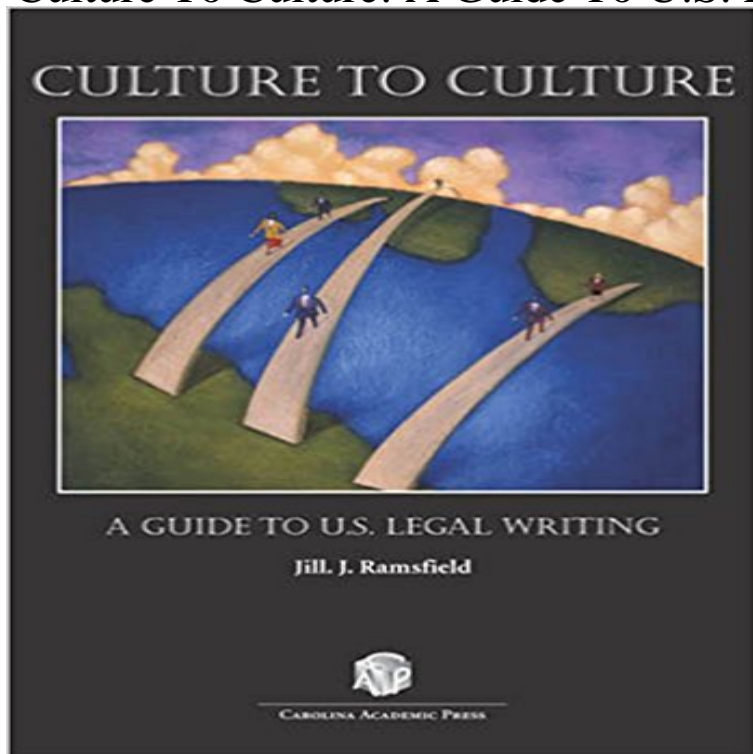


## Culture To Culture: A Guide To U.S. Legal Writing
