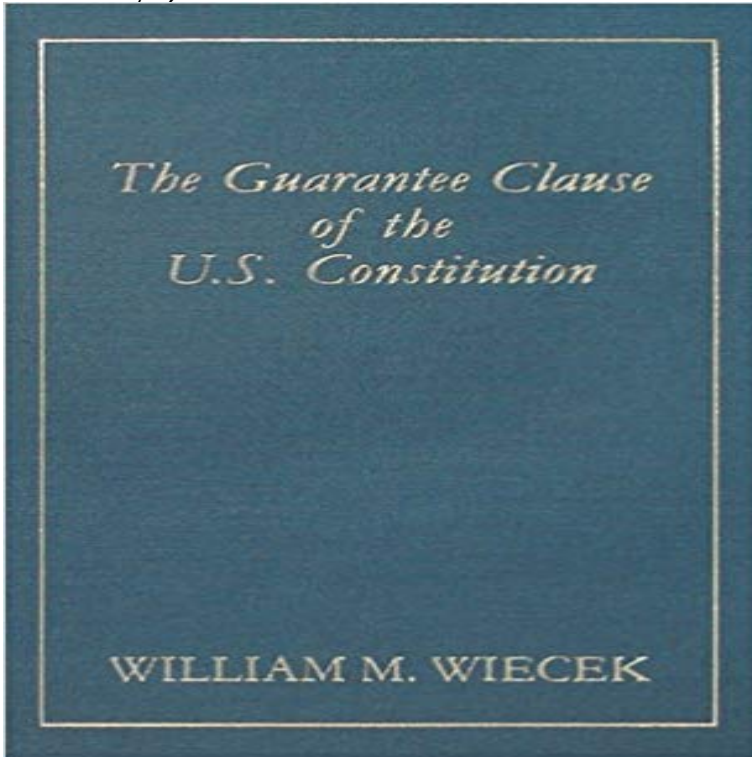


The Guarantee Clause Of the U.S. Constitution (Cornell Studies in Civil Liberty.)
