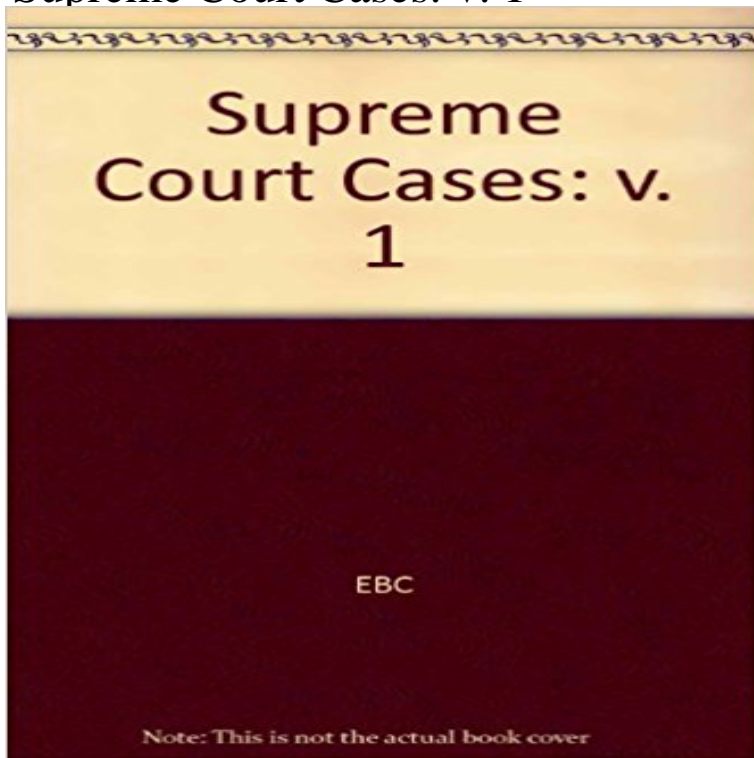


Supreme Court Cases: v. 1
