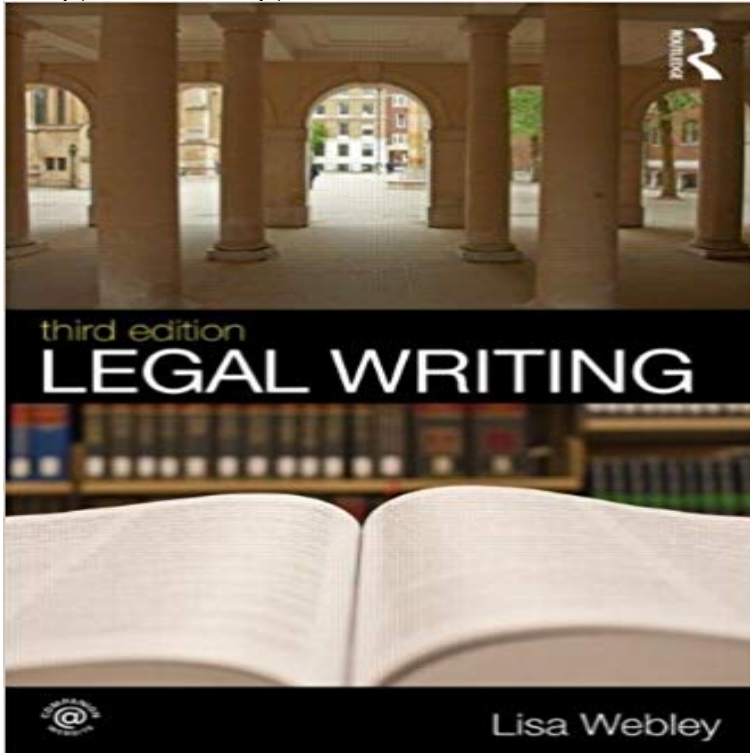


## Legal Writing
