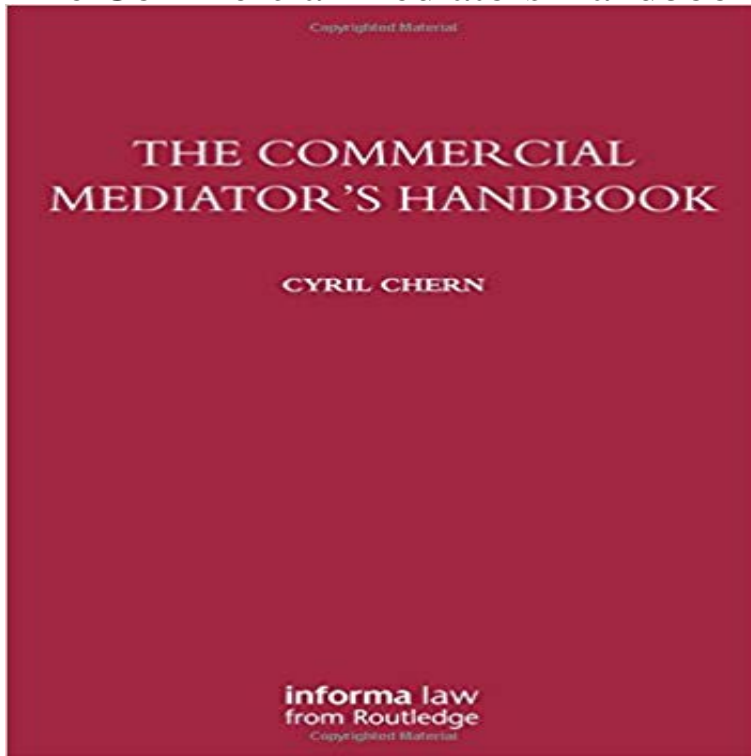


# The Commercial Mediators Handbook
