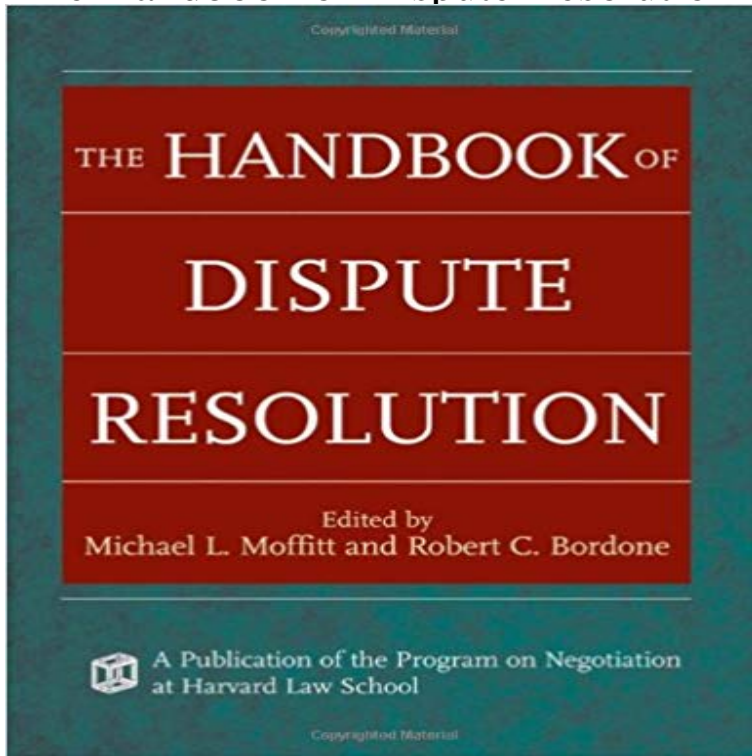


The Handbook of Dispute Resolution
