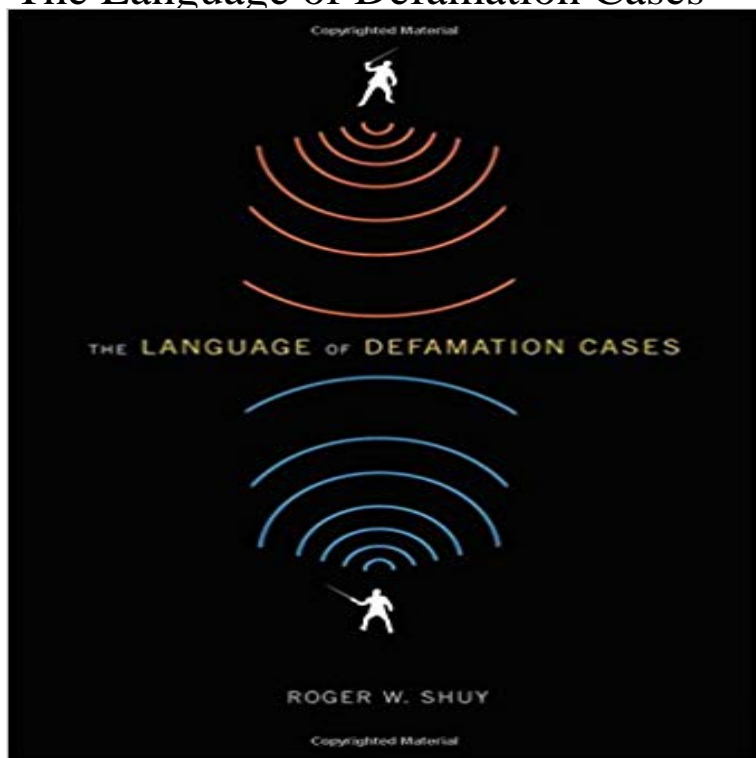


The Language of Defamation Cases
