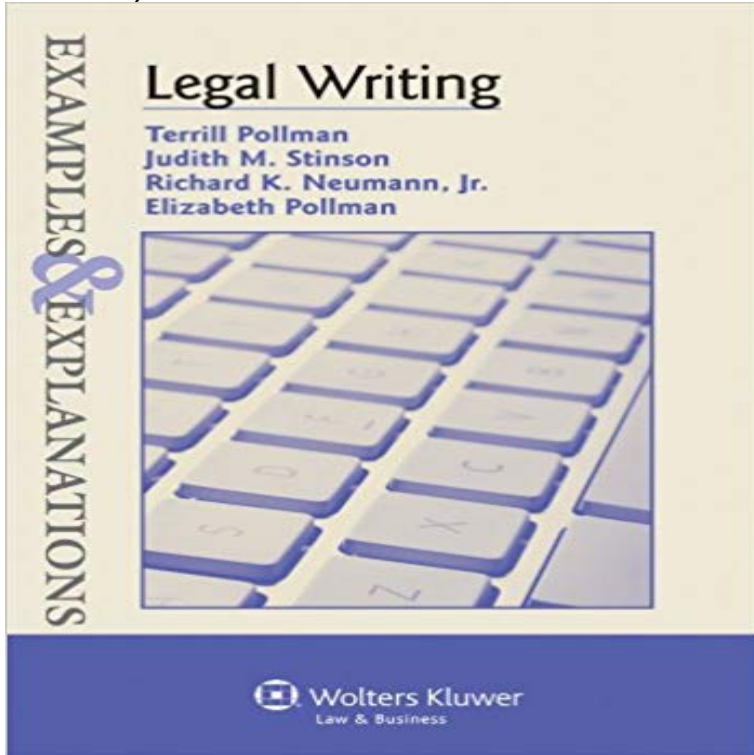


Legal Writing: Examples & Explanations (The Examples & Explanations Series)
