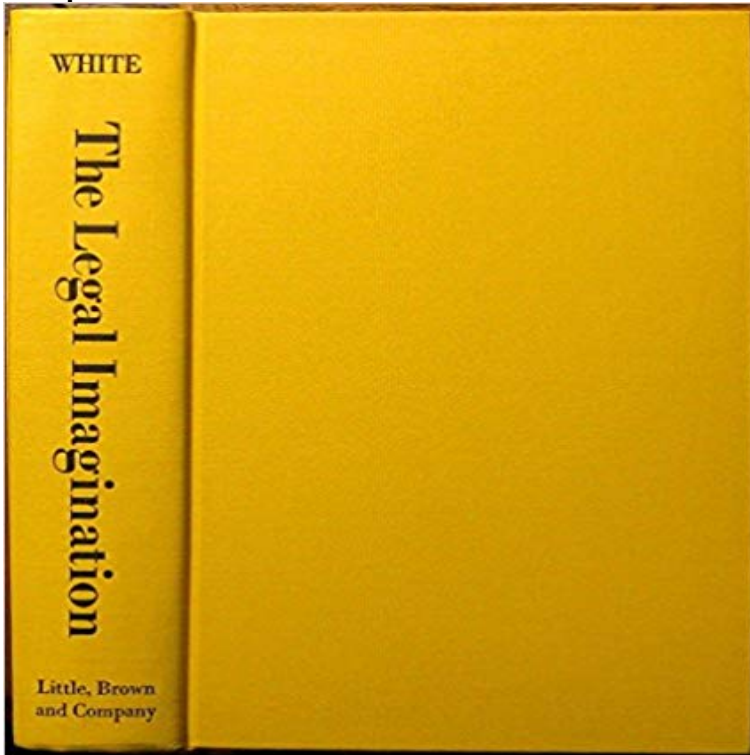


# Legal Imagination: Studies in the Nature of Legal Thought and Expression
