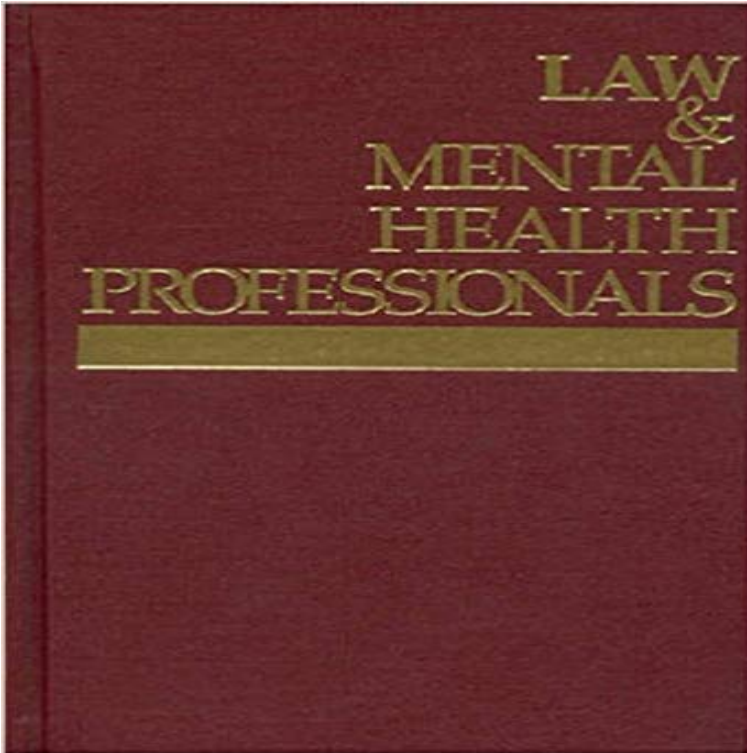


## Law & Mental Health Professionals: Massachusetts
