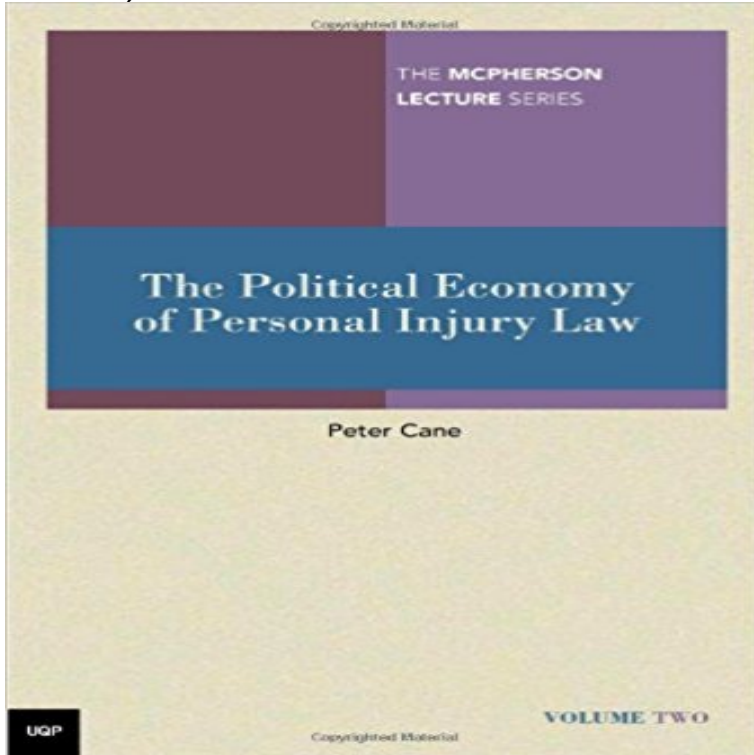


## The Political Economy of Personal Injury Law (The McPherson Lecture series)
