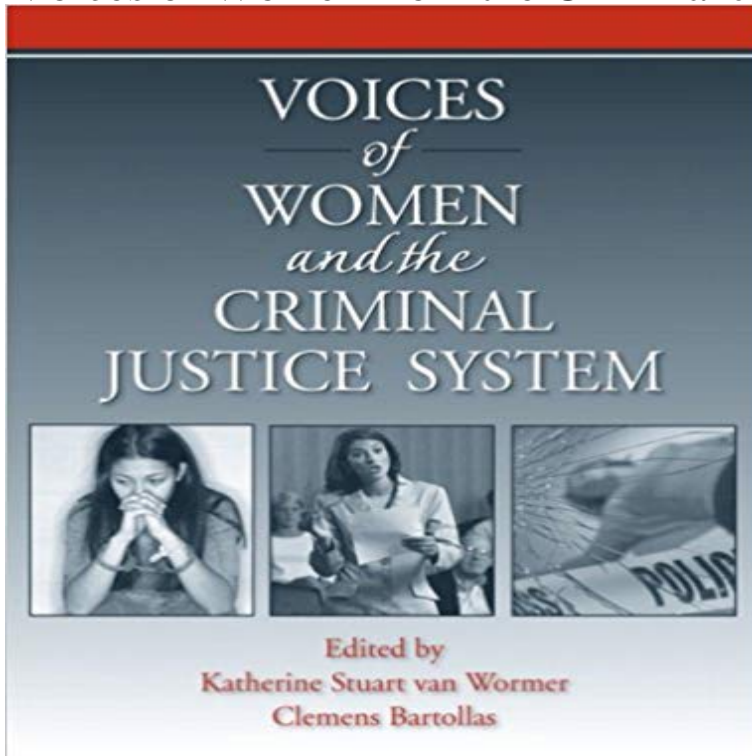


Voices of Women from the Criminal Justice System
