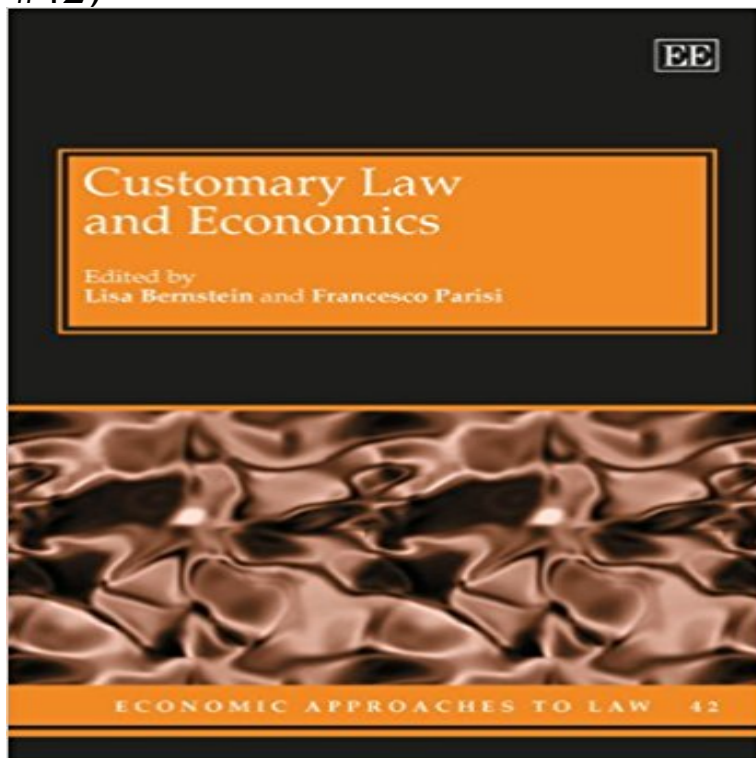


## Customary Law and Economics (Economic Approaches to Law series, #42)
