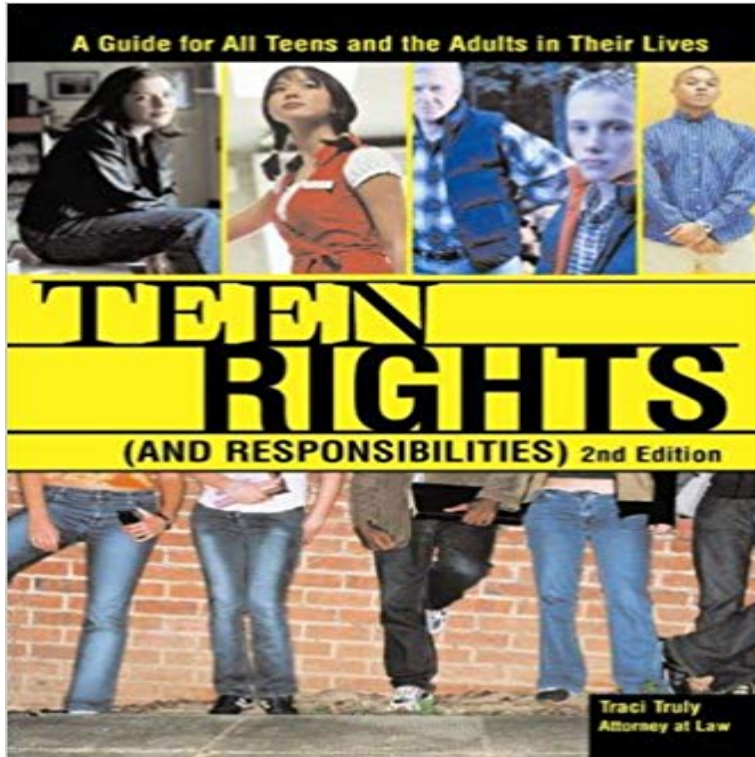


# Teen Rights (and Responsibilities): A Guide for All Teens and the Adults in Their Lives
