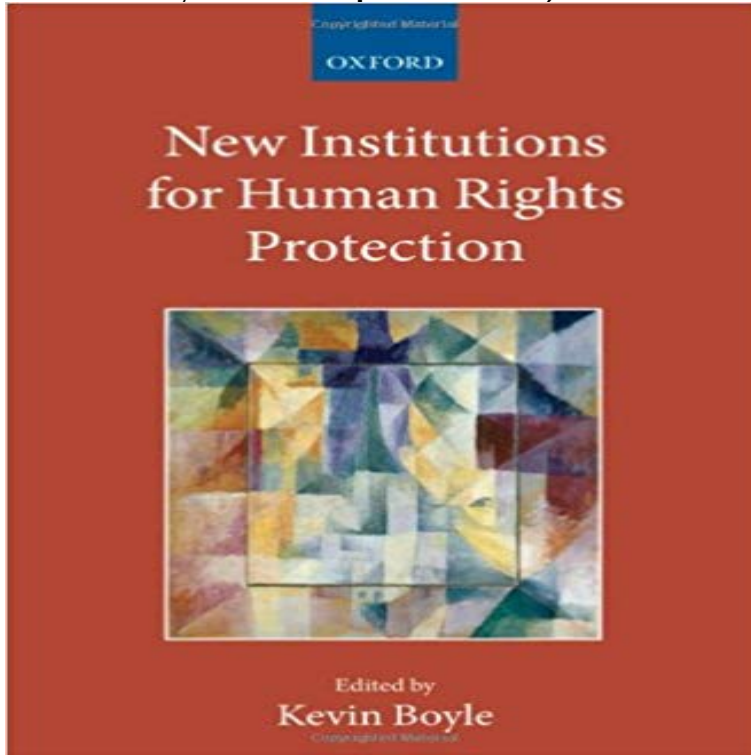


# New Institutions for Human Rights Protection (Collected Courses of the Academy of European Law)
