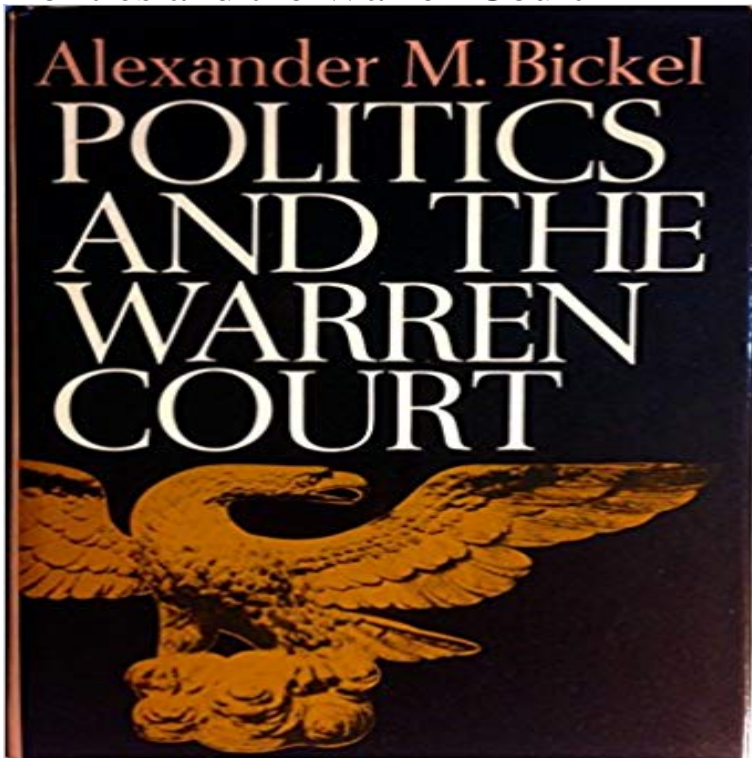


## Politics and the Warren Court
