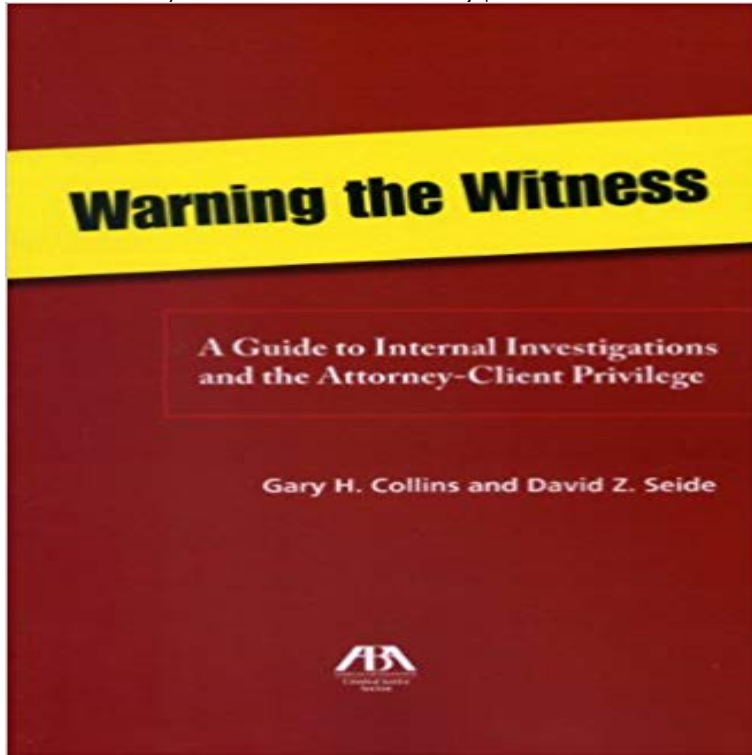


# Warning the Witness: A Guide to Internal Investigations and the Attorney-Client Privilege
