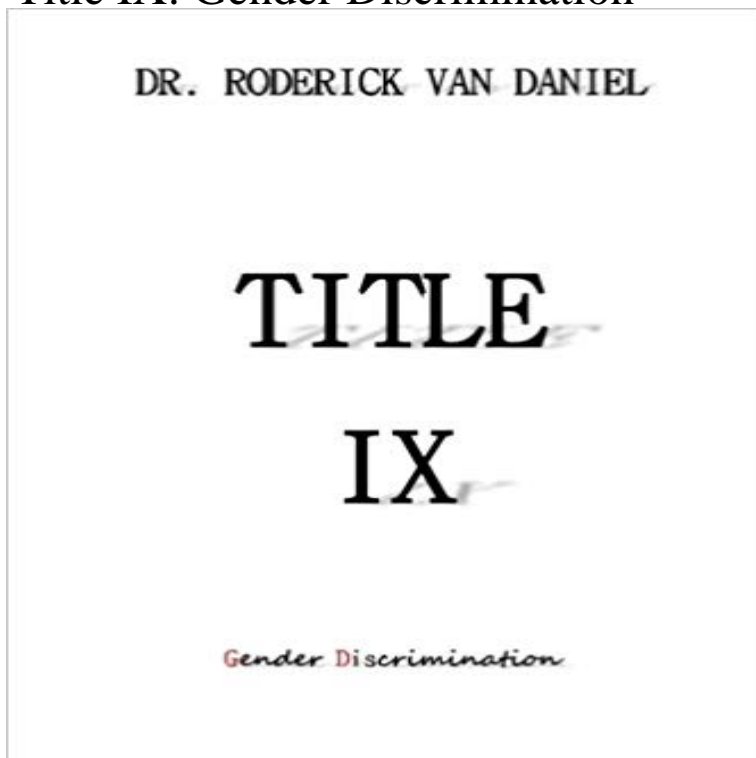


## Title IX: Gender Discrimination
