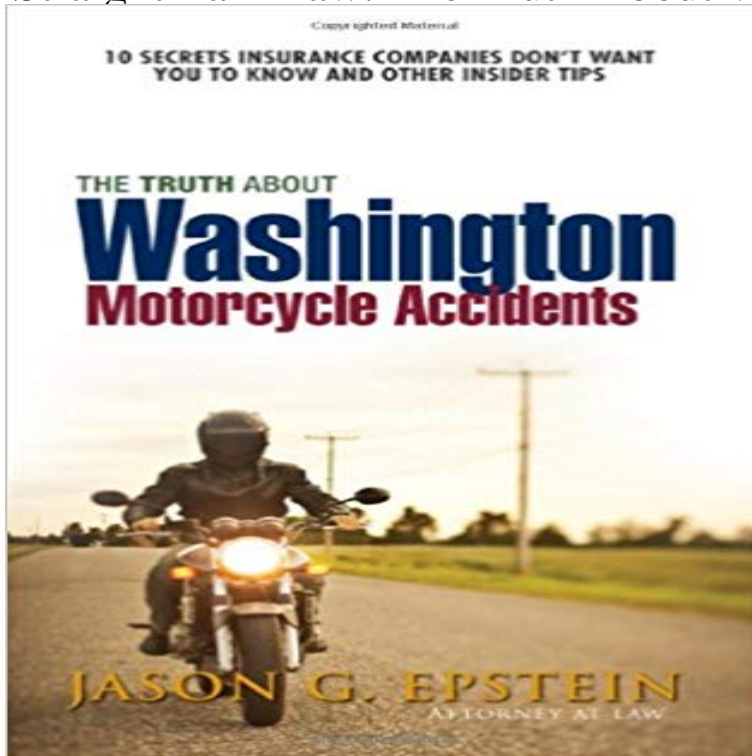


Straight Talk Law: The Truth About Washington Motorcycle Accidents
