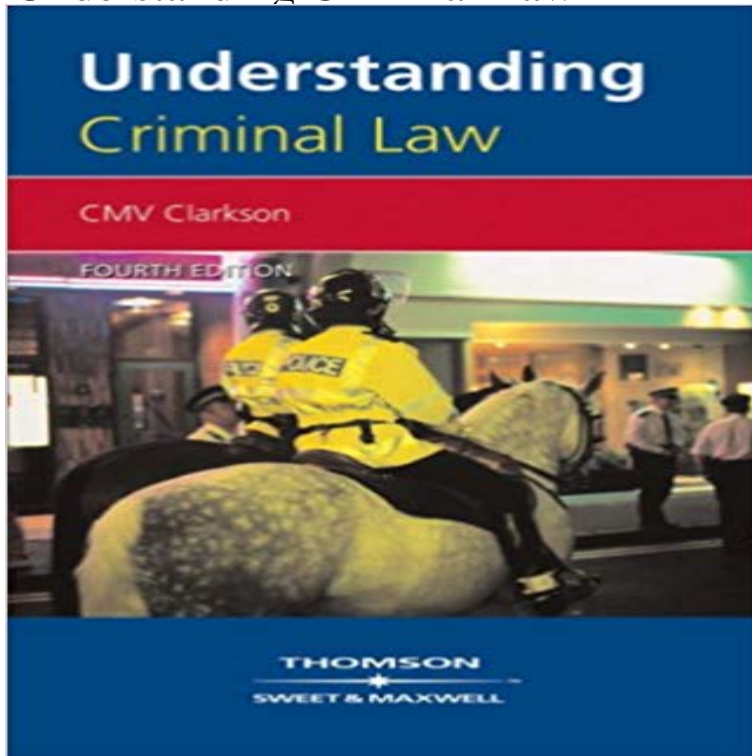


## Understanding Criminal Law
