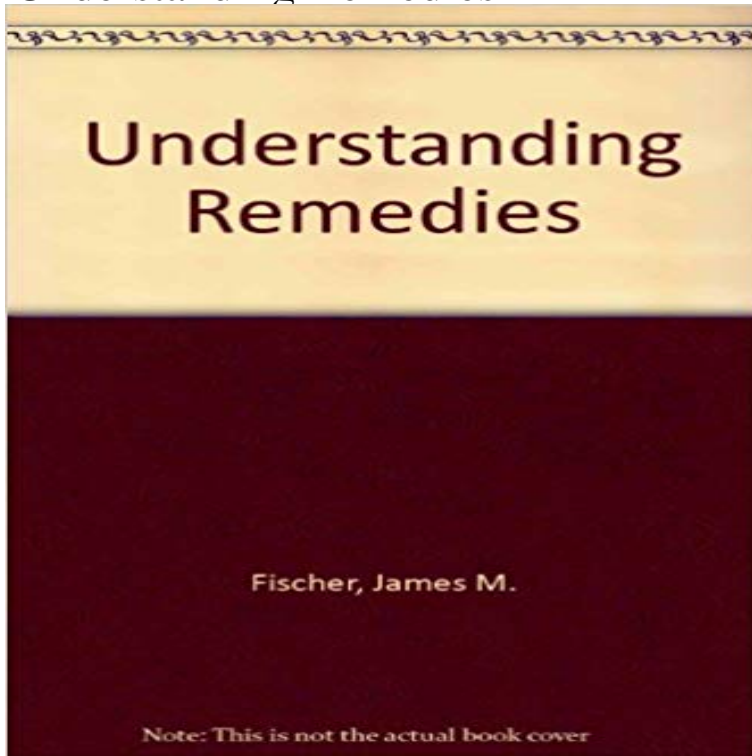


## Understanding Remedies
