

# Obstruction of performance under Article 86(2) and its application to the water sector



Master Thesis at the University of Bremen. The author argued that due to characteristics of the water sector, it qualifies for exemption under EC Competition Rule, Article 86 (2). The paper elaborate how this exemption will apply in practice, and compares them with EC cases on other utilities, such as electricity and gas.
