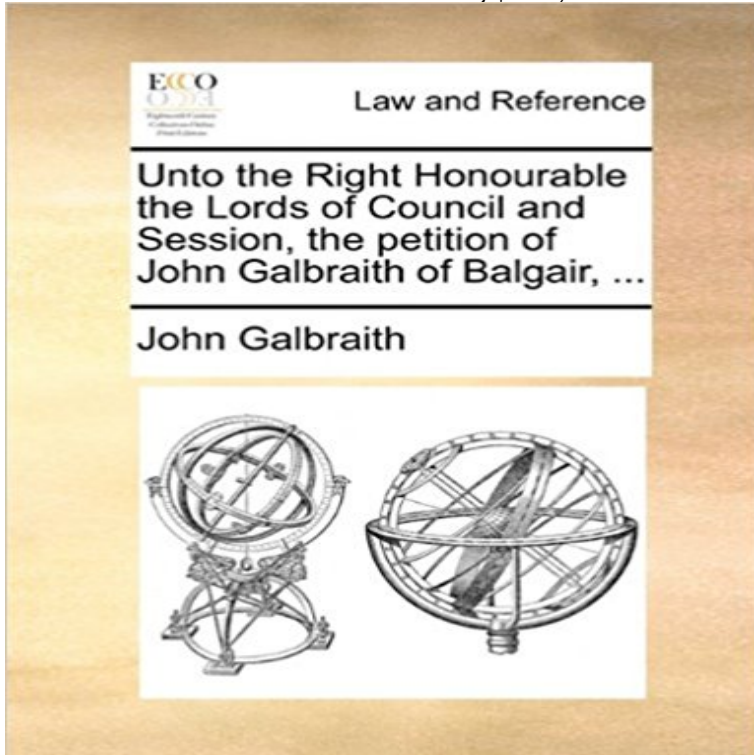


# Unto the Right Honourable the Lords of Council and Session, the petition of John Galbraith of Balgair, ...
