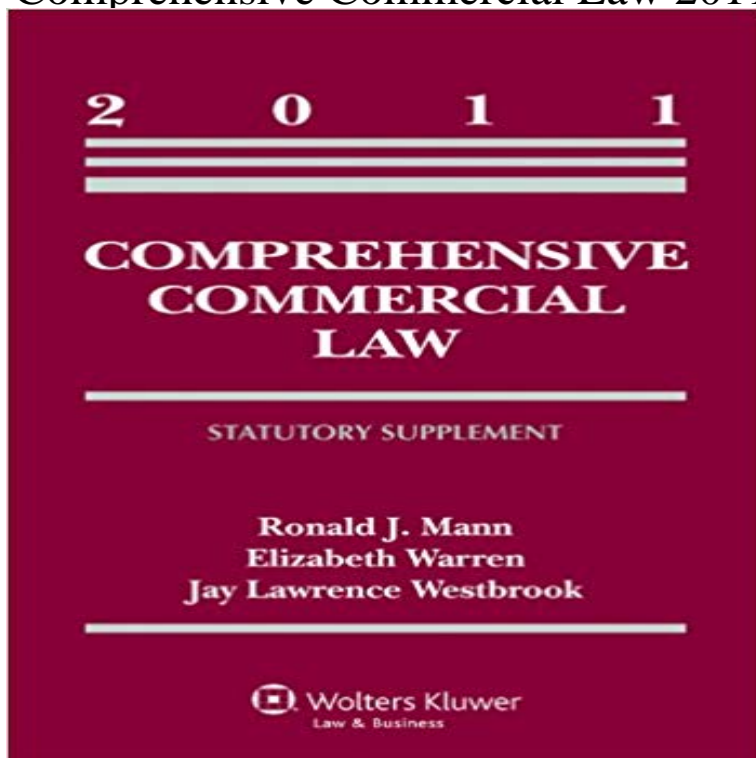


## Comprehensive Commercial Law 2011 Statutory Supplement
