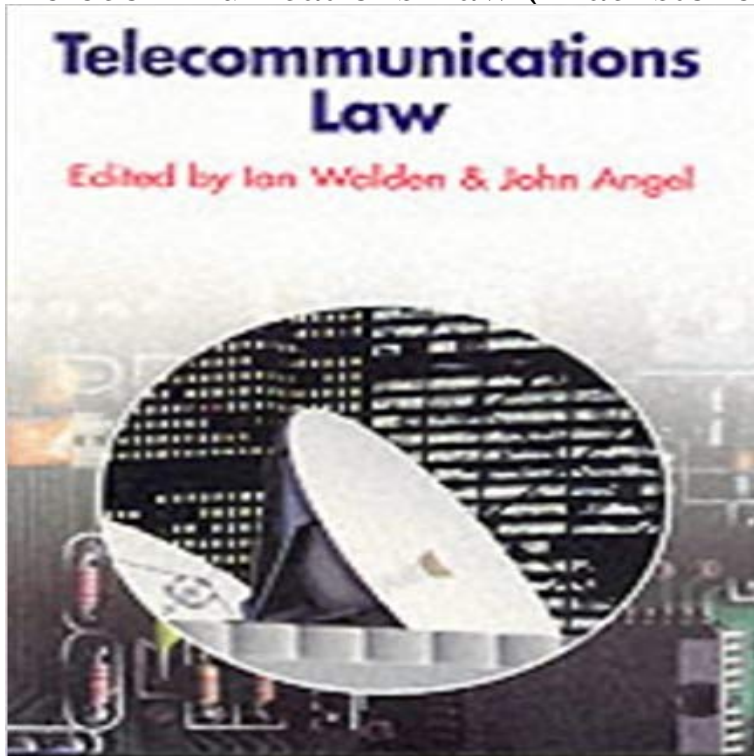


## Telecommunications Law (Blackstone Press)
