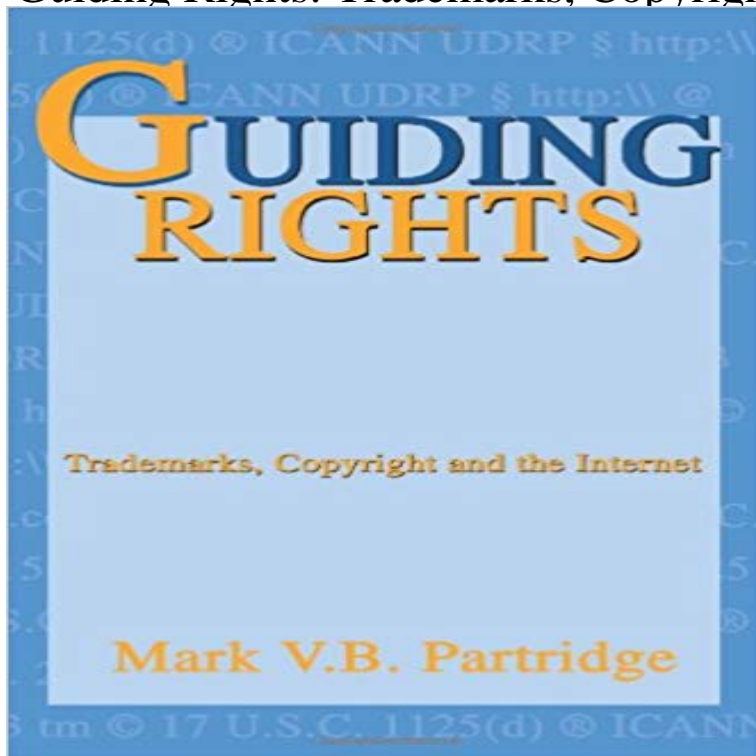


## Guiding Rights: Trademarks, Copyright and the Internet
