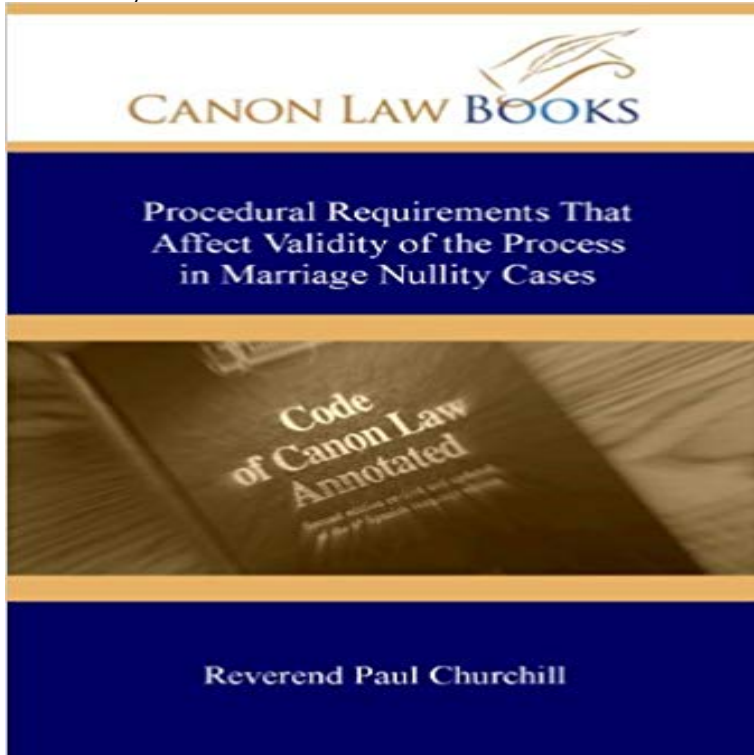


Procedural Requirements That Affect Validity of the Process in Marriage Nullity Cases
