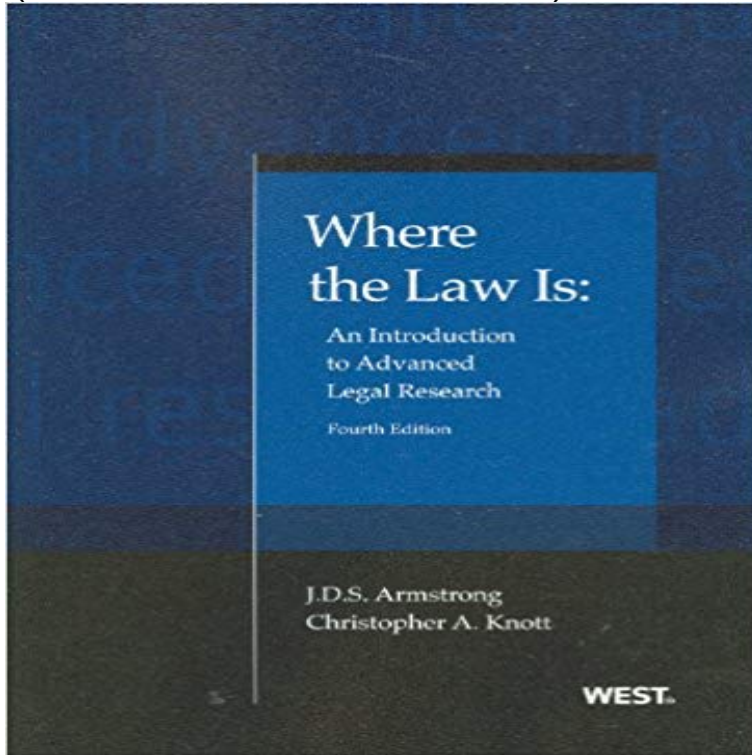


## Where the Law Is: An Introduction to Advanced Legal Research, 4th (American Casebook Series)
