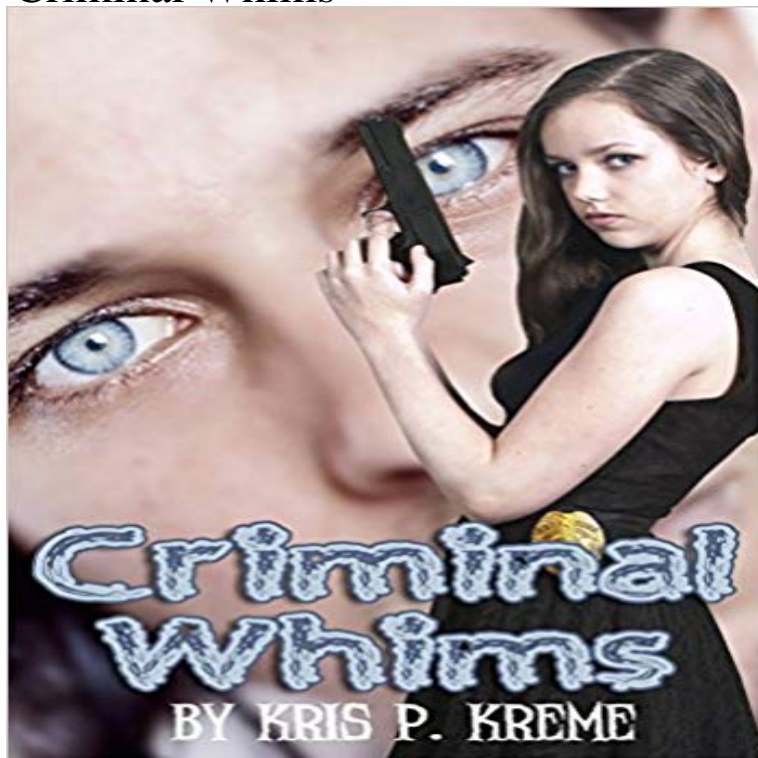


Criminal Whims
