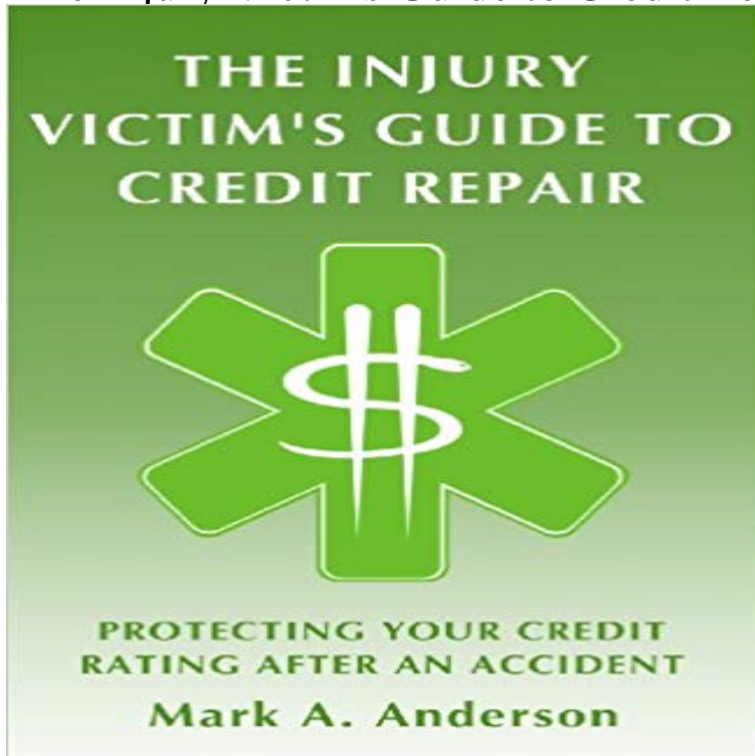


## The Injury Victims Guide to Credit Repair
