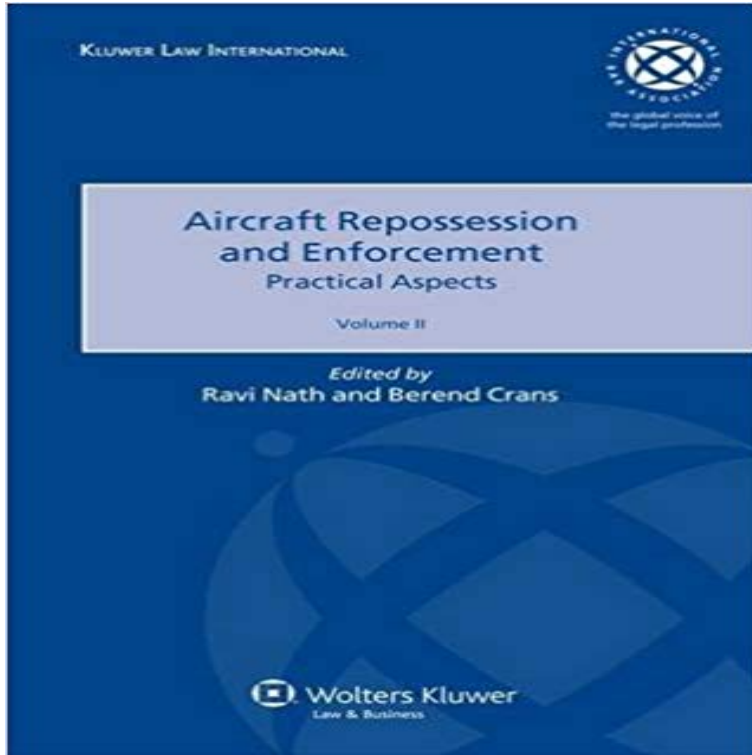


Aircraft Repossession Enforcement Practical Aspects Volume II (Kluwer Law International: International Bar Association)
