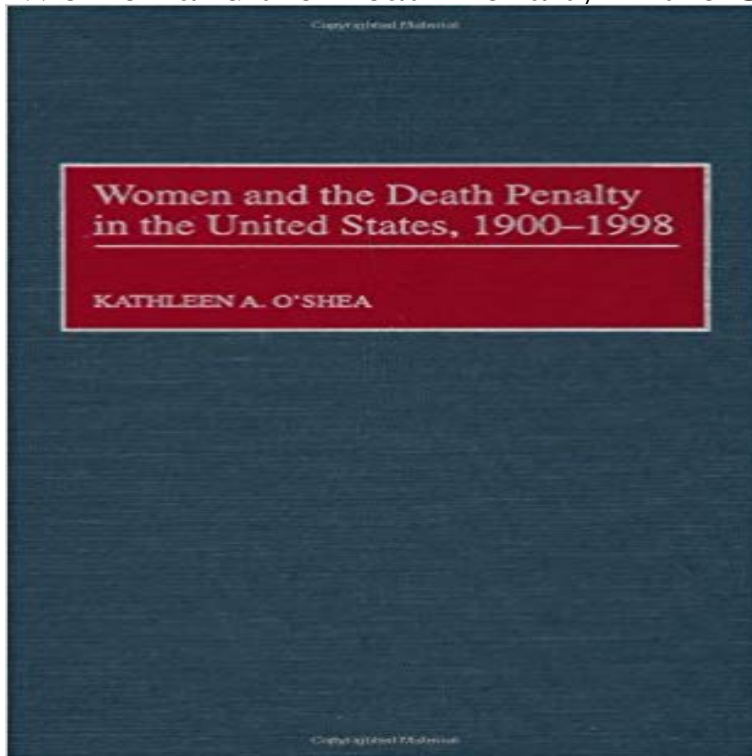


Women and the Death Penalty in the United States, 1900-1998
